Ohio ARES VHF Simplex Contest Helps Operators Plot Coverage Areas

Ever wonder how far you can reach on VHF/UHF frequencies? On January 8, from 10 AM to 4 PM, Ohio ARES members answered that question. It was the *ARES Ohio VHF plus Simplex Contest*, with all amateurs having been invited. Bands used were 6 meters, 2 meters, and 70 cm. Entry categories were Fixed, EOC, and Rover. Bonus points were given out by ARES officers (AEC, OES, EC and above). Complete <u>rules, submission forms, and other pieces of information</u> were promulgated. Participants entered their operating plans on the website. W8SGT was in operation from the Ohio state EOC this year. It's a contest with a purpose: ARES and other operators plot their simplex coverage area to know where they could dependably communicate on simplex during an emergency.

Results: <u>Stan Broadway, N8BHL, Ohio Section Emergency Coordinator</u>, reported on the results: Forty-eight logs were submitted, including five from the Rover stations. On average, eight counties were contacted by each station, with two reporting 18 counties worked, one Rover reporting 22 counties worked, and one fixed station reporting a whopping 34 counties contacted. Thirteen stations reported contacting double-digit counts of counties.

Joe Wigal, W8JTW, was heard across the state - he operated from the N8OJ tower site in Washington County with a 2 meter antenna height of 190 feet, and 280 watts of RF output. He also worked the 6 meter antenna with a height of 150 feet and 100 watts. Wigal worked 27 Ohio counties and seven in West Virginia for a total of 34 counties. He worked eight of the 10 Ohio ARES Districts, and five of the 10 West Virginia ARES Districts. His furthest contact was 163 air miles on 2 meter FM. He said, "Was fun, looking forward to next year."

Soapbox: "I was operating fixed and it was fun to follow the Rovers to various counties. I made contacts with Rovers in six counties." "First time participant. Nice way to spend a Saturday afternoon monitoring 2m, 6m, and giving points to the Rovers and fixed stations I could hear and get back to." "Great participation in northwest Ohio. Worked five Rovers! Furthest contact was 107 miles on 6 meter FM. Had a great time, lots of really good operators in our area!" "It was lots of fun, taught me a lot about my equipment, working through pileups and propagation challenges, making new friends and connecting with old ones and more." "I operated as a Rover in Mahoning, Trumbull, Portage, and Summit counties. Another excellent event this year, thanks to all who helped organize and participate!"

Greetings to all Club Members,

With all that has happened these last few years it is getting harder and harder to be merry, even during the Holiday Season. Sad as it has been of late, it is still better than no Holiday Season. Club Trailer update

There has been some interest as to the current status of the trailer improvements that are under consideration by the "Trailer Committee." Some of the other factors that have come into play with it are: the demands of pressing club business, preparations for our annual Holiday Party, and other projects. As a result trailer improvements have been relegated to the back burner for now. Still there are some members who have been curious as to what is happening with this project.

To put things in perspective, here are some of the relevant projects that predate the actual work on the Trailer Project, these had to be dealt with first. Because of the pressing need to take care of the many things that need attention, some careful planning and preparation was needed. A fully functioning repeater system for normal communications as well as emergency communications is of primary importance, so it must be monitored and maintained before any other project can be considered.

Some years ago, it was noted that our basic repeater system had deteriorated to the point where some thing needed to be done to improve it's flagging performance. It was determined that first of all we needed new feed line installed on the WXOW tower so that we could assure continued efficient operation on our repeater. In 2004 a study was conducted by a committee and they found that what we could afford to put into place was Andrews Heliax coax feed line. The feed line along with all of the other hardware elements needed to complete the project were located and procured. The new feed line was installed on the tower in 2007 and has been in service ever since.

Recently, the WXOW station was going to need an upgrade of its transmitter, tower, and connecting lines, so we worked it out with their tower climber to also check over our feed line, connections and do basic maintenance on our antenna system as well. This was achieved at no extra cost to the club. Next we invested in a new Yaesu DR-2X digital/analog repeater and installed it in the cabinet at WXOW's station. That all brought our system up to date and with some adjustments it has been working fairly well.

This brings us to our communication trailer itself. It was originally supposed to be a self contained emergency communication unit. As time wore on, the things needed to achieve such a goal were determined, it had become obvious that even if we were able to make it self contained and able to get on the air anywhere, no one seemed to be interested in the sort of communication help that this could be provided by it. Other groups have a much more usable units for that purpose. Whether or not their units would be used for that purpose is not clear. Our best option with our trailer is to use it for special events, like Field Day or Parks on the Air, and as a training/educational unit.

To Clarify Things.....

Recently there has arisen a misunderstanding of some of the things in the RARC Constitution, Standing Rules, and By Laws regarding the elections that annually take place. First, it must be pointed out that several years ago, due to a lack of progress in the governance of our club, it was decided to change the nature of our monthly meetings. We used to include in our monthly meetings all of the business aspects of running our club.

This worked fine for a time, until it became obvious that due to a strict adherence to the rules of order, little was actually being done in our meetings. So to facilitate a more progressive atmosphere it was agreed that we would eliminate the business portion of our monthly membership meeting, by moving all of the regular business items of those meetings to the Executive Board for them to deal with. This is not to say that the general membership would have no say in the running of the club. Far from it, it merely freed up the time that was designated for the monthly meetings so that more interesting and meaningful topics could be presented to those attending our meetings.

Through the re-crafting of our Constitution, Standing Rules, and By Laws, a more workable arrangement was achieved. We currently are using the approved 2017 Constitution, Standing Rules, and By Laws which enabled changes to take place that made this possible. It all worked well for several years that the Executive Board would deal with the normal business of running the club. The idea was to enable the Executive Board to make decisions needed to make things happen on a level that didn't require the approval of the general membership.

The Board was granted the authority to make purchases and other minor decisions on it own. This included the ability to spend up to \$500 on a given project or purchase without the formal approval of the membership. Anything that came up that would cost more than that would have to be approved by a majority vote of the entire membership. It also restructured the election process by the nomination and election of the Executive Board itself, rather than the officers on it. This really streamlined the whole process, but it did create some confusion as to what was actually being voted upon in our elections.

Those who assume the various offices on the Executive Board are decided by the Board itself, not by the general membership. So you see that only the Executive Board itself is elected, not the officers, the officers are agreed upon by the Executive Board members themselves. Thus a more team like approach to who actually runs the club is achieved.

The Executive Board meets monthly and all of the members of the club are welcome to attend those meetings and add their input to what the Executive Board is discussing. Unless the items under consideration require a vote of the general membership, the Executive Board has authority to make them happen.

Recently, our Constitution, Standing Rules and By Laws have come into question. It has been pointed out that there are several things in them that are vague or conflicting. As a result a total review if those documents is underway by a legal expert to help resolve any issues in those documents.
